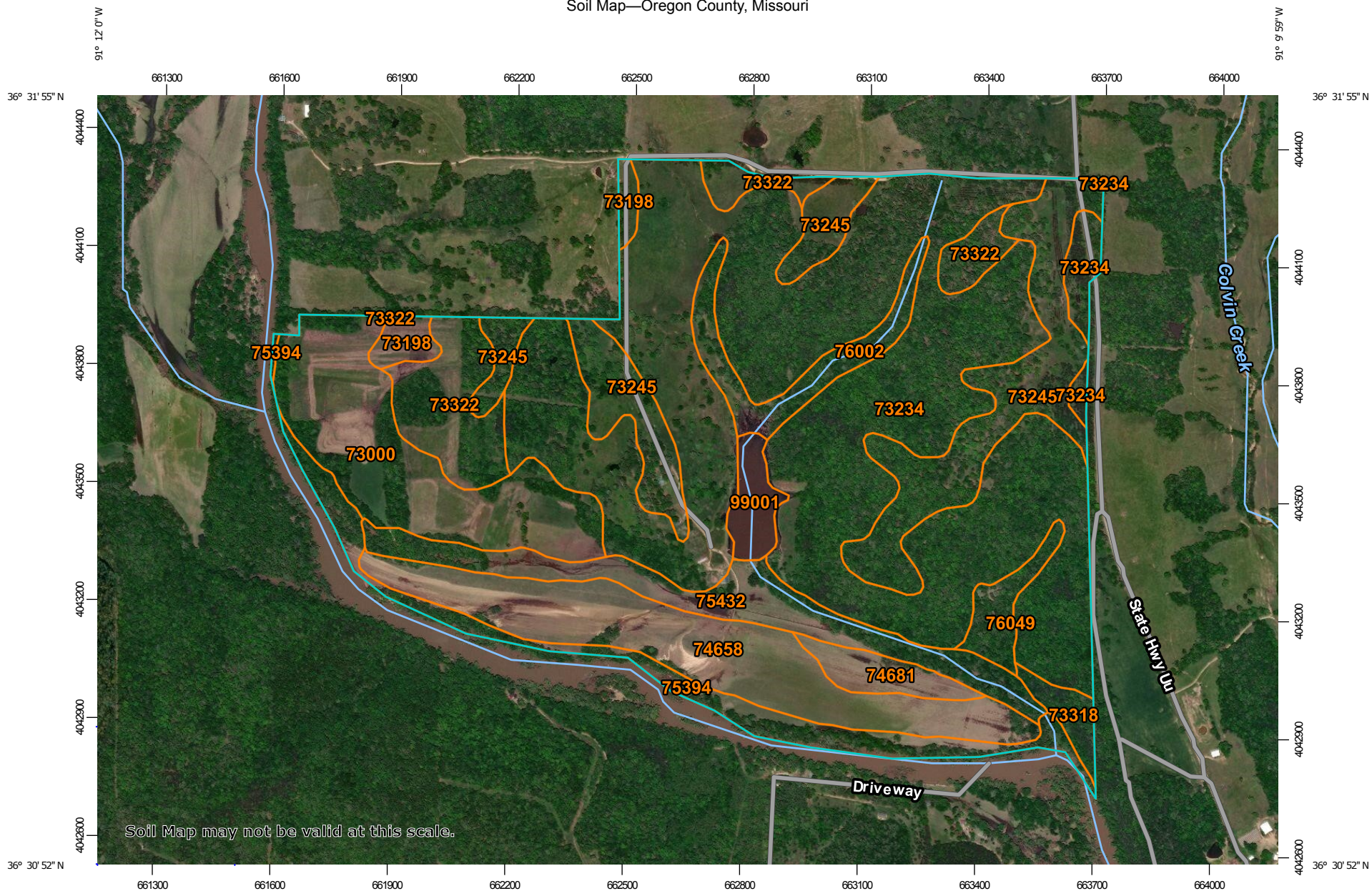
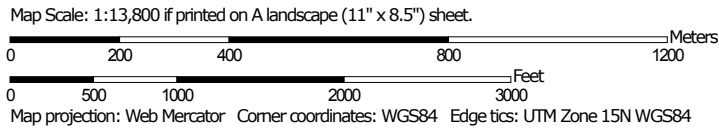


Soil Map—Oregon County, Missouri
